Evergreen seeks a full-time Advocacy Lead to lead the organization's engagement with Capitol Hill and support policy development to build bold, justice-centered policies to decarbonize our economy and transition to an equitable 100% clean energy future. The primary responsibilities will include working with the policy team to develop and advocate for policy products to effectively tackle the climate crisis, based on our three pillars of standards, investments and justice. This work will dovetail and enhance the the clean energy standards, federal investments, and prioritization of environmental justice being pursued by the Biden Administration The ideal candidate will have a demonstrated commitment to environmental justice, strong interpersonal skills, knowledge of government, experience in legislation, policy research and analysis, a deep understanding of climate policy, and 2-4+ years experience working on federal climate policy or politics, ideally including Hill experience.
